



H. APPROVAL CRITERIA

Prior to approving any application for Historic District Review, the Historic District Approval Authority must find that the following criteria have been met:

- (e) ... Alternate-energy Devices: Wind-generators, solar collectors, and similar alternate energy devices may be utilized-only if they can be installed in a manner in which they are not visible from a public way.
 - Solar arrays, whether photovoltaic or thermal, may be utilized on buildings; if the arrays are not visible from a public way or: if they are installed on a roof rack system which keeps the panels as close as possible to the roof, on the same plane as the roof, and do not intrude on the façade of the building.
 - 2. Other alternate energy devices including wind generators may be utilized only if they can be installed in a manner in which they are not visible from a public way.

WHEREAS, in the course of updating and managing the Butler Head Conservation Easement, it has been determined that there is an encroachment of a septic disposal system on property of the City for the benefit of a dwelling on adjacent property now owned by the Pine Irrevocable Trust dated December 19, 2014; and

WHEREAS, an agreement has been reached by all of the parties, the City of Bath, the Pine Trust, and the Kennebec Estuary Land Trust, that there be a swap of property that would place most of the septic disposal system on property to be acquired by the Pines, and to provide an Easement for the small additional area remaining on Bath property; and

WHEREAS, the Agreement also provides for the granting of an Easement for access to the Pine Trust property from the Mallard Road in order to relocate the access drive; and

WHEREAS, the land swap involves the identical amount of land, 7,990 square feet.

NOW, THEREFORE, BE IT ORDERED by the City Council of the City of Bath that a swap of the property in equal amounts by and between the Pine Trust and the City of Bath, with the consent of the Kennebec Estuary Land Trust, to be accomplished by an exchange of Deeds, together with an Easement for a portion of the septic disposal system area still encroaching on the City of Bath property and to relocate the Pine Trust access drive, be and hereby is approved and the City Manager is authorized to execute such Deeds and Easement, in substantially the form as attached hereto, and such other documentation that may be necessary, appropriate or convenient to the consummation of this transaction and subject to his review and approval.

Assistant City Manager Marc Meyers spoke regarding the Order and the background and the actions that will take place regarding all three of the properties. City Solicitor Theriault gave description of the properties and the important pieces of the project. Mr. Chair commented that the Forestry Committee is behind the approval of these Orders.



RE: Land Use Code Amendment to Articles 9 and 11 regarding short term rentals

Background

In 2019 the community development committee requested staff and the planning board to begin the process of amending the Land Use Code to create legislation for short term rentals after hearing concerns from a few residents and local business owners that there was not a process in place to ensure that short term rentals met basic life-safety requirements and were not causing undue hardships on the surrounding neighborhood. The request was to create an ordinance that would codify where short term rentals could operate and to determine appropriate performance standards to dictate how their operation would occur. The amendment would work in conjunction with current local and state guidelines on short term rentals.

The request for a Land Use Code Amendment was reviewed by the Planning Board in workshop setting beginning in late 2019. The Planning Board held workshops on the item both in person and remotely with a hiatus of a few months at the beginning of the pandemic. The Planning Board held two public hearings on the proposed ordinance during the August 25th and December 1st Planning Board meetings. In the December 1, 2020 meeting the Planning Board voted not to recommend the passage of the amendments to the Land Use Code regarding short term rentals to the City Council.

During workshop sessions the Planning Board spent a considerable amount of time reviewing ordinances from other communities (both from within Maine and from "away") and listening to concerns from residents and business owners both for and against any ordinance amendment. Throughout the process there seemed to be little consensus from those that attended workshops on how to best implement the policy. Throughout the process it has been hard to gauge how much impact short term rentals have (positively or negatively) as there is currently no way of knowing how many exist outside of a basic search of online platforms. The lack of citizen complaints related to short-term rentals (only one complaint has been submitted to the Codes office since the state building codes were updated to allow short term rentals (of which the City follows)) was certainly a point of conversation for the Planning Board and was central to the

intentions of the ordinance to create a very basic set of performance standards.

While the Board did not state a reason for voting not to recommend, there was much discussion during workshops around the appropriateness of creating performance standards on a use that does not currently cause many complaints. The Board also struggled with determining the correct locations to allow short term rentals (should they be allowed in some, all, or no residential areas) and struggled with the balancing of finding performance standards that would not be too overbearing but would allow for fewer disruptions of everyday life for neighborhoods where short term rentals operate.

Ultimately, the Planning Board determined that the current provisions in place in the Land Use Code and state building codes would be sufficient for now. Currently under the Land Use Code, a homeowner can rent out a bedroom in a single-family home to up to three individuals for a short- or long-term basis and meet the requirements of in-home lodging as defined in the Land Use Code. Entire dwelling units (single family, two family, or multi family dwellings) can be rented on a short-or long-term basis provided the dwelling meets certain building and potentially life-safety requirements. While the Land Use Code as it stands does not define short term rentals, nor does it require short term rentals to meet certain performance standards in order to operate, it does allow for individuals to operate short term rentals within the City of Bath.

Additionally, to hopefully not confuse things too much, I had shared with the Board that I expected a Land Use Code amendment to go hand in hand with a licensing process that would track short term rentals that are operating within the City. Any license provisions would be handled in the City Code similar to the regulations for any other licensing as detailed in Chapter 5 of the City Code. Portland, Rockland, and other communities (which staff and the Planning Board reviewed) have established licensing provisions that require registration and certification in order to operate a short-term rental. The City Council could direct staff or a council subcommittee to review and draft a short-term rental licensing ordinance as an amendment to the City Code with or without a Land Use Code component.

Council Action

The City Council can take several different approaches to the Planning Board's determination to recommend not approving the Land Use Code amendment. If the Council determines that the Land Use Code amendment has merit the Council can vote to approve the ordinance. If the Council agrees with the Planning Board and determines that the amendment lacks merit, then action on the amendment to the Land Use Code will cease. The Council could also vote to table review of the item in order to remand the Land Use Code amendment back to the Planning Board for review of specific sections of the proposed ordinance.

ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BATH THAT THE LAND USE CODE OF THE CITY OF BATH ADOPTED JULY 19, 2000, AND SUBSEQUENTLY AMENDED, BE HEREBY FURTHER AMENDED AS FOLLOWS:

AMEND ARTICLE 11: PERFORMANCE STANDARDS:SPECIFIC LAND USES BY ADDING:

SECTION 11.40 SHORT TERM RENTALS

Short-term rentals are the use of legally existing single family, two-family, and multi-family dwelling units for the accommodation of short-term guests, for compensation, for periods of less than one month. They are only allowed in legally existing dwelling units. The intent of this ordinance is to ensure the safety of the occupants of the short-term rental as well as to minimize the impact of such use on the surrounding neighborhood. All short-term rentals shall meet the applicable criteria listed within the Land Use Code, and must meet the following standards:

- A. A Short-term Rental Type A shall include a single-family dwelling where the rental includes at least one room for rent for a period of less than one month in an owner-occupied unit. A Short-term Rental Type A shall also include a dwelling unit in a two-family dwelling in which one dwelling unit is occupied by the owner and the other unit has at least one room for rent for a period of less than one month.
- B. A Short-term Rental Type B shall include the rental, for the period of less than one month, of an entire single-family dwelling or one or both dwelling units of a two-family dwelling, where the owner does not reside on site. A Short-term Rental Type B shall also include the rental of one or more dwelling units of a multi-family dwelling, where at least one room is available for rent for a period of less than one month.
- C. The maximum occupancy of a Short-Term Rental Type A shall be not more than two guests per bedroom and shall not exceed a total of three guests per dwelling unit.
- D. The maximum occupancy of a Short-term Rental Type B shall be not more than two guests per bedroom and shall not exceed ten guests per dwelling unit.
- E. The short-term rental may not produce any odors, noise, or other nuisances in excess of that produced by normal residential use.
- F. There may be no external alteration of the building or site that changes its residential character.


- G. The short-term rental shall comply with the parking requirements detailed in Section 10.06. Additionally, the short-term rental must ensure there is at least one additional parking space for each room to be rented on a short-term basis in addition to the requirements of Section 10.06.
- H. The short-term rental shall demonstrate compliance with applicable building, fire prevention, and life safety codes upon review from the Code Enforcement Officer and Fire Chief or their designee. In addition, no recreational vehicles, trailers, tents, or other mobile residential equipment other than a mobile home may be permitted or rented as a short-term rental.
- I. The applicant for a short-term rental shall provide the name, address, telephone number, and email address of a person who will be responsible for management of the short-term rental. A Short-Term Rental Type A shall provide proof that the owner resides at the property.
- J. The minimum stay period for any short-term rental shall be from one night up to less than one month.
- K. A Short-Term Rental Type A as defined by this ordinance shall be reviewed and may be approved by the Staff Review Committee.
- L. A Short-Term Rental Type B as defined by this ordinance shall be reviewed and may be approved by the Planning Board.
- M. To the extent necessary the Review Authority has the right to impose restrictions on maintenance activities and operations of a short-term rental where such restrictions are necessary or appropriate to prevent or mitigate the impact of the use on abutting or neighboring properties. Restrictions may include, but are not limited to, snow removal, refuse removal, and the use of parking facilities.




